Alliance Global Allots P7 B for Tourism Projects

Tycoon Andrew Tan's Alliance Global Group Inc. is setting aside P7 billion for new tourismrelated projects outside Metro Manila to show its strong commitment and confidence in the tourism industry in the Philippines.

"Tourism is poised to become the country's next sunshine industry," said Alliance Global President Kingson Sian. "By strengthening its public-private partnership program, the Aquino administration is opening the country to more infrastructure investments and making Philippine tourist destinations more accessible," he said.

"Alliance Global's new tourism projects outside Metro Manila will create synergies with its ongoing Resorts World Manila at Newport City in Pasay City. All these will help boost the country's image as a prime tourist destination in the region," Sian said.

Resorts World Manila is the first integrated tourism development of its kind in the Philippines. It features the country's largest casino, the five-star Marriott Hotel, the six-star, all-suites Maxims Hotel, both operational, as well as the upcoming Remington and Belmont hotels, along with a 1,500-seat performing arts theater, fine dining restaurants and an upscale shopping mall.

Since the opening of Resorts World Manila in August 2009, the number of visitors to the complex has reached the two millionth mark. Alliance Global expects foreign visitors to Resorts World to reach 800,000 within the next three years. This easily translates to tourist receipts of at least US\$1 billion.
